Yes, it's time to start planning for the summer! We are again partnering with East Liberty Presbyterian Church this summer for a wonderful week of Vacation Church School.


Vacation Church School

From Missouri to Malawi:

One Great Hour of Sharing God's Love

On the last three Sundays of March, Sixth Church will receive your donations to the annual **One Great Hour Sharing.** This is one of the three Presbyterian special offerings that we collect every year.

The purpose of **One Great Hour of Sharing** is to share God's love with our neighbors in need both in the United States and throughout the world – from Missouri to Malawi. Your gift to **One Great Hour of Sharing** will deliver relief to those affected by natural and human-caused disasters, provide food to the hungry, and support communities working to cast off the bonds of poverty, neglect, and oppression.

As I reviewed the work supported by One Great Hour, I was surprised – and frankly saddened – to learn that a large number of grants go to communities in our own country. Of course, many grants made to American organizations are responses to disasters, but many others address hunger and broader challenges faced by poor communities and marginalized groups. They support programs that address hunger, housing, environmental and even civil rights issues that these communities continue to face.

Because our news feeds focus on "the next big story," it is far too easy to forget the unseen, yet persistent, reality faced by our sisters and brothers, in our own country and around the world, where poverty, disasters, and war cause massive suffering. Here are just two organizations which your donations support to address these issues.

In Missouri, funds from One Great Hour support the work of the Castlepoint Neighborhood Organization, which is helping this impoverished St. Louis community toward a better future by "establishing a steady stream of resources within the neighborhood," including a community garden that has produced hundreds of pounds of fresh vegetables, as well as efforts to improve housing and the local environment.

In Malawi, Kasupe Ministries serves over 12,000 people living in southern Malawi through community-designed programs that provide health care, schools and scholarships, programs to support and improve local agriculture, and emergency assistance to those in need of food, clothing, and temporary shelter.

Presbytery Passes Corporate Engagement Overture Endorsed by Sixth By Tom Twiss

On Thursday, Feb. 22 the Pittsburgh Presbytery approved an "overture" (or resolution), endorsed by Session at Sixth, urging the General Assembly of the PC(USA) to "direct the Committee on Mission Responsibility Through Investment (MRTI) to begin 'focused engagement'" with two companies in which PC(USA) invests: General Electric (GE) and Palantir Technologies, Inc. The purpose of this engagement would be to move the two companies toward compliance with the policies of PC (USA). The overture was written by two members of the steering committee of the PC(USA)'s <u>Israel-Palestine Mission Network</u> — Bob Ross, from the East Liberty Presbyterian Church, and me.

Our reason for writing the overture was our conviction that the ongoing activities of both companies are inconsistent with the values of the PC(USA). Our denomination has a long tradition of putting its money where its values are. Back in 1971 the General Assembly <u>affirmed</u> that church investment is not just a practical question; it's an "instrument of mission" that includes "theological, social and ethical considerations." Consistent with that, the PC(USA) has <u>identified</u> various practices that can qualify a company for divestment. These include military production, especially when the weapons produced are being sold to states where there are heightened risks of serious violations of international humanitarian law. Another divestment criterion is the operation of the company in conflict-affected and high-risk areas where there are widespread human rights abuses and violations of national or international law.

The practices of both companies are *exactly* the sort of activities our divestment policies have been created to address. GE produces engines and/or crucial parts for all the fighter jets, Apache helicopters, and Sa'ar warships employed by Israel in the bombing and blockade of Gaza. Its engines are also found in the jets and helicopters used by Saudi Arabia to bomb Yemen. And in China, GE is a customer of companies that participate in the forced transfer, re-education, and exploitation of the oppressed Uyghur population. Palantir has created the predictive policing technology that is used to jail Palestinians simply because they fit a "terrorist profile" and that has contributed to the incarceration of as much as 40% of the total male population of Palestine. Its technology is also utilized in the U.S. by ICE to carry out workplace raids, deportations, and the separation of migrant families, and by local U.S. law enforcement agencies for the police profiling that is widely recognized as racist. While our denomination invests in these companies, we unintentionally contribute to, and profit from, these practices financially.

The first Pittsburgh-area church to endorse this corporate engagement initiative was Valley View Presbyterian in Garfield. Shortly after that, the January meeting of our Session unanimously approved the overture, which had been submitted to it by our Justice Team. On Feb. 22, it was introduced by Rev. Chad Collins of Valley View at the meeting of the Pittsburgh Presbytery, where it was approved by a vote of 79 to 12.

Two presbyteries or synods must endorse an overture before it can be considered by the General Assembly. In fact, the San Francisco Presbytery passed it the week before Pittsburgh, and since Feb. 22 it has been approved by the Mid-Kentucky Presbytery. So, it is now clear that it will be going to the General Assembly meeting at the end of June. If it is approved there, MRTI will initiate a dialogue with GE and Palantir to bring their practices in line with our Christian values. Failing that, MRTI would be charged with making "possible divestment recommendations."
